Dear Commissioners,

This is an invitation for your County to participate in the selection process for the **2017-2019 Community Dispute Resolution Program (CDRP) Grant Funds** pursuant to ORS 36.160.

Assuming funding for 2017-2019 is reauthorized by the 2017 Legislature at the same level as the prior biennium, grant funds for Lincoln County will be approximately \$50,000.00 for the period July 1, 2017 - June 30, 2019. The funding for these grants is currently derived from an appropriation from the general fund for the purpose of providing dispute resolution services in counties and will be allocated per University of Oregon policy.

Enclosed is a review of all of the information necessary to proceed with the Request for Application (RFA) process.

The first step in the local selection process is the County's adoption of a resolution to participate. ORS 36.160 requires that a County notify the Oregon Office for Community Dispute Resolution (OOCDR) of its intent to participate in the selection process to award grant funds. A sample county resolution is provided in the enclosed RFA packet. Upon your County's adoption of the resolution, please send a copy to the OOCDR. Following is the timeline for the 2017-2019 grant process:

By March 31, 2017 County Commission adopts a resolution of desire to participate in the process.

April 3, 2017 Legal notice published by the County to announce the application process (sample included). The County and OOCDR make RFA packets available to applicants.

April 28, 2017	Applications must be received by 5:00 p.m. at the County and OOCDR.
May 31, 2017	OOCDR issues notices of eligibility to applicants and County.
June 9, 2017	Any appeals from applicants determined ineligible by OOCDR must be received by 5:00 pm.
June 15, 2017	County Commission selects grantee(s) and notifies OOCDR of selection.
June 30, 2017	OOCDR enters into Grant Agreement with the grantee(s).

According to University of Oregon policy, each County Commission needs to designate a County dispute resolution program coordinator. OOCDR staff provides technical assistance and advice to this County staff person to make sure the process runs as smoothly as possible. If you have received this letter and are not the County's dispute resolution program coordinator, please forward these materials to the proper person.

OOCDR encourages collaboration in all phases of the grantee selection process. In some Counties there will be only one interested and qualified applicant. However, if your County receives applications from more than one qualified applicant, we encourage you to have conversations with all applicants to determine whether there are ways for them to work together to best provide dispute resolution services in your County.

You may elect to opt out of the selection process if you desire. In that case, the Dean of the University of Oregon School of Law will assume the county's role in the process. If this is your choice, please provide OOCDR with a written notice to opt out by March 31, 2017. A sample Opt Out notification form is available upon request.

OOCDR will also provide you with electronic versions of the RFA, as well as a sample 2017-2019 Grant Agreement. Feel free to contact me at 541-346-1623 if you have any questions. Thank you in advance for your support.

9 WHEREAS Lincoln County Code (LCC or Code) Chapter 1 contains the County
10 Comprehensive Plan, Zoning, Land Division and other implementing provisions for Land
11 Use Planning; and

12 WHEREAS LCC 1.1230 authorizes the Board of Commissioners, by Resolution, to
13 initiate legislative amendments to the Code, after public hearing by the Planning
14 Commission and receipt of the Commission's recommendations; and

15 WHEREAS the County, by Ordinance #466 dated August 8, 2012, and later by
16 Ordinances #473 and 477, adopted and amended the Bayshore Dune (Foredune)
17 Management Plan and Strategy (hereinafter known as the "Bayshore Plan"), and
18 implementing Code provisions into Chapter 1 to address foredune sand problems within the
19 Bayshore area of south Lincoln County; and

20 WHEREAS the application of provisions of the Code as amended have allowed the
21 County to consider adjustments to the Plan to better serve the needs of the County and
22 community residents in addressing these sand issues; and

23 WHEREAS following consultation with parties who helped develop the code
24 provisions, including Oregon State Parks and the Oregon Department of Land Conservation
25 and Development and the Department of Geological and Mineral Industries, the County has
26 determined that an adjustment of the Code revising the boundaries of the Plan area (Dune
27 System) would be of benefit to overall management of the sand issues; and

28 WHEREAS the Board desires that the staff and Planning Commission consider
29 revisions to the adopted Code provisions to consider an alternate boundary; and

WHEREAS the Board desires to initiate a review process for possible Code changes
under the County Code;

NOW, THEREFORE, the Board of Commissioners does resolve:

1. That pursuant to LCC 1.1230, an amendment(s) to the Lincoln County Comprehensive Plan and Codes to address an alternative boundary for Bayshore Plan is initiated and

1 referred to the Lincoln County Planning Commission. This includes any changes to
2 maps, descriptions, system identification or other changes to make the boundary shift.
3 The Planning Director shall set a date for a hearing or hearings before the Planning
4 Commission and provide notice as required under LCC 1.1250 and state law to consider
5 alternatives. The Planning Commission shall make a recommendation to the Board after
the public hearing(s). Staff shall prepare recommended alternatives for Planning
Commission consideration.

- 6 2. That copies of this Resolution be provided to the Planning Director, who will notify the
7 Planning Commission, and County Counsel.
