WHEREAS, the Lincoln County Board of Commissioners has established a Nonprofit Social Service Agency Allocation Review Committee to make recommendations in helping to fund private nonprofit social service agencies within Lincoln County; and

WHEREAS, for fiscal year 2017-2018, funds in the amount of \$175,050 have been allocated to fund this program; and

WHEREAS, the Nonprofit Social Service Agency Allocation Review Committee met on May 18, 2017, to review requests submitted by nonprofit social service agencies and has submitted its recommendations to the Board of Commissioners; and

WHEREAS, after review of the recommendations and discussion at the Board's May 31, 2017 public meeting;

NOW, THEREFORE IT IS HEREBY ORDERED THAT:

1. The funding recommendations made by the Nonprofit Social Service Agency Allocation Review Committee for fiscal year 2017-2018 are approved and adopted as follows:

2. Each agency shall submit a request for payment, on a quarterly basis unless otherwise approved by the Board, to the Director of Finance and Accounting, 210 SW 2<sup>nd</sup> Street, Newport, OR 97365.


3. The Board may limit the use of funds for selected agencies and shall do so through notice to the agency.

4. The Board may review the allocations at any time to determine if any agency continues to be a viable service provider within the community and make such modifications to the allocation as it determines necessary.

5. Copies of this Order shall be provided to the Finance Director/County Budget Officer Janice Riessbeck, Grants Administrator Julie Kay, and to each of the agencies listed above.
