This measure results from a petition referring Ordinance 262 to the Yachats voters. If the voters approve this Ordinance, a five percent (5%) tax will be imposed on the total amount charged by a seller for all food and non-alcoholic beverages sold in restaurants as defined by the Legislation. The tax will commence on July 1, 2007 and be collected quarterly by the City. The taxes collected will be used to pay for a portion of the costs for improvements to the sanitary or storm water systems or the water system of the City. Providing a public hearing is held following required published notice, the Council may increase the rate of tax initially imposed by the Legislation. If a candidate receives a majority of the votes, then that candidate's name is the only name to appear on the November general election ballot. If no candidate receives a majority of the votes, then the names of the two candidates receiving the highest number of votes appear on the November ballot. Voters may write-in candidates on all ballots. The combination of the requirement that a candidate receive a majority vote in order to win and the right of voters to write-in candidates on all ballots means it is possible that no one will receive a majority of the votes in November, thus causing a Council position to remain vacant.</p> <p>This Charter amendment will reduce the process of conducting a May primary and November general election to one election in November, with write-in votes allowed.
