

BEFORE THE BOARD OF LINCOLN COUNTY COMMISSIONERS

ORDINANCE NO. 30 ✓

AN ORDINANCE TO AMEND CERTAIN ORDINANCES HERETOFORE ENACTED TO CORRECT ERRONEOUS NUMBERING OF SAID ORDINANCES.

WHEREAS, certain ordinances heretofore enacted and duly adopted by the Lincoln County Board of Commissioners have been erroneously numbered, and as a result of such errors several ordinances are misnumbered; and

WHEREAS, such duplication in numbering of said Ordinances will lead to confusion and uncertainty with respect to the laws of Lincoln County,
NOW, THEREFORE, THE LINCOLN COUNTY BOARD OF COUNTY COMMISSIONERS ORDAINS AS FOLLOWS:

Section 1: That there have been three Ordinances zoning portions of Lincoln County, which have been designated by short title as "Zoning Regulations - Lincoln County, Oregon", and on each of said Ordinances being designated by short title as Lincoln County Zoning Ordinance of 1971". It is hereby, therefore, provided that Zoning Ordinance #24 enacted and filed on April 21, 1971, which describes no specific or particular property, be and the same shall remain as Ordinance No. 24. It is hereby further provided that the aforesaid Ordinance above referred to is attached hereto with identification marked on the cover thereof of "Exhibit A - Lincoln County Zoning Ordinance No. 24".

Section 2. That the said Ordinance No. 24 enacted and filed on April 21, 1971, which is attached hereto, marked "Exhibit B - Lincoln County Zoning Ordinance #24-B" is hereby changed to be and shall hereafter be known as Lincoln County Zoning Ordinance No. 24-B.

Section 3. That the said Ordinance heretofore adopted on the 21st day of April, 1971, and entitled "Yaquina Bay Zoning Areas - 25" be and the same is hereby changed to Lincoln County Yaquina Bay Zoning Ordinance No. 25.

Section 4: That said Ordinance No. 25 entitled "An Ordinance Setting Forth Rules and Regulations for County Park Areas and Providing for Appointment of a County Park Superintendent" be and the same is hereby renumbered as Ordinance No. 28; that a copy of said Ordinance is attached hereto, the same being recorded in Book 6, page 1179 in the Commissioner's Journal, the purpose of attaching the same hereto being for identification purposes and reference.

Section 5: That that certain Ordinance numbered 24 and enacted on the 28th day of December, 1971, filed and recorded in Book 5, page 1143 of the Commissioners Journal and entitled "Building Code - Lincoln County, Oregon" be and the same is hereby changed and renumbered and shall hereafter be known as "Lincoln County Building Ordinance No. 29"; that a copy of said ordinance is attached hereto for reference and identification.

Section 6. That except as herein specifically altered all of the conditions, provisions and stipulations in said Ordinances shall remain in full force and effect.

Section 7. Inasmuch as the provisions herein contained are necessary for the preservation of the peace, health and safety of the inhabitants of all zoned

areas within Lincoln County, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect upon its enactment.

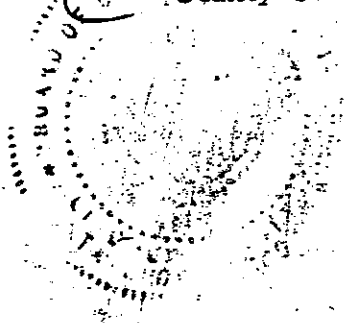
