BEFORE THE BOARD OF COUNTY COMMISSIONERS  
FOR THE COUNTY OF LINCOLN  
Ordinance No. 87

AN ORDINANCE PROHIBITING THE USE OF FIREARMS AND OTHER WEAPONS  
IN THE ECKMAN LAKE AREA, AND DECLARING AN EMERGENCY.

The Lincoln County Board of Commissioners ordain as  
follows:

SECTION I, DEFINITION

As used in the Ordinance, firearm means a weapon, by  
whatever name known, which is designed to expel a projectile by  
the action of black powder or smokeless powder, and which is  
readily capable of use as a weapon.

SECTION II, FINDINGS

The Lincoln County Board of Commissioners finds that:

(A) The area surrounding Eckman Lake in Lincoln  
County has become urban in character, although not within  
an incorporated city.

(B) The use of firearms and other weapons upon  
and around Eckman Lake creates a clear and present danger  
to the public safety of residents around the lake and the  
users of the lake.

SECTION III, PROHIBITIONS

It is unlawful for any person to fire or discharge any  
bow and arrow, air rifle or firearm within 150 feet or upon the  
surface of Eckman Lake in Sections 28 and 29, T 13 S, R 11 W, W.M.,  
in Lincoln County, Oregon.

1 SECTION IV, PENALTY


2 Violation of Section III of this Ordinance shall be

4 SECTION V, EMERGENCY CLAUSE


5 This Ordinance is necessary for the immediate preserva-
