3 Ordinance # 124

4 AN ORDINANCE PROVIDING FOR THE COLLECTION OF FEES BY THE LINCOLN  
5 COUNTY CLERK AND DECLARING AN EMERGENCY

6 The Lincoln County Board of Commissioners ordains as  
7 follows:

8 SECTION I. FEES

9 The Lincoln County Clerk shall collect the following  
10 fees in addition to all other fees required by law:

11 (1) \$50 for conciliation services as provided by  
12 ORS 107.510 to 107.610.

13 (2) \$20 for an original appearance fee in adoption  
14 and change of name proceedings.

15 (3) \$4 for docketing district court or justice of  
16 the peace judgments in the Judgment Docket of the Circuit Court  
17 as provided by ORS 46.274, and 52.630.

18 (4) \$4 for filing the termination of a cooperative  
19 contract as provided in ORS 62.360.

20 (5) The schedule set forth below for the checking  
21 of subdivisions by the county surveyor as provided in ORS 92.100:

22 (a) \$50 for subdivision containing 10 lots or  
23 less.

24 (b) \$100 for subdivisions containing over 10, but  
25 not more than 25 lots.

26 (c) \$200 for subdivisions containing over 25, but

- 1 not more than 50 lots.
- 2 (d) \$300 for subdivisions containing over 50, but  
3 not more than 100 lots.
- 4 (e) \$500 for subdivisions containing over 100 lots  
5 and \$5 for each additional lot.
- 6 (6) \$5 for approval by the board of county commissioners  
7 of subdivision plats.
- 8 (7) The schedule set forth below for recording and indexing  
9 subdivision plats:
- 10 (a) \$10 for plats containing 20 lots or less.
- 11 (b) \$15 for plats containing over 20 lots and less  
12 than 30 lots.
- 13 (c) \$20 for plats containing 30 lots and less than  
14 50 lots.
- 15 (d) \$25 for plats containing 50 lots and less than  
16 75 lots.
- 17 (e) \$30 for plats containing 75 lots and less than  
18 100 lots.
- 19 (f) \$50 for plats containing over 100 lots and an  
20 additional charge of 50¢ per lot for all lots  
21 over 100.
- 22 (8) \$3.50 for filing an "Authority to Solemnize Marriages"  
23 as provided in ORS 106.120.
- 24 (9) \$5 per page for preparing a true copy of a document not  
25 sufficiently legible to be reproduced photographically.
- 26 (10) \$25, plus \$10 per hour, for time spent in excess of

1 2 hours, for a lien search and certificate as provided in ORS 205.230.

2 (11) \$1 for every tract or lot indexed in the direct or  
3 indirect index, pursuant to ORS 205.340.

4 (12) \$10 for the marking of vacations on an original plat  
5 by the county surveyor as provided by ORS 271.230.

6 (13) \$10 for filing a notice of a mine claim or for a  
7 mining lien as provided in ORS 517.030.

8 (14) \$10 for filing affidavits of labor on mining claims.

9 (15) \$10 for a certificate of assessment work on a mining  
10 claim as provided in ORS 517.290.

11 SECTION II. EMERGENCY CLAUSE

12 That this Ordinance being necessary for the immediate pre-  
13 servation of the public peace, health, and safety, an emergency is  
14 declared to exist, and this ordinance takes effect on its adoption.
