4 AN ORDINANCE ADOPTING CHAPTER ONE OF THE LINCOLN COUNTY CODE, RE-
5 PEALING AND AMENDING CERTAIN PREVIOUS ORDINANCES, READOPTING CERTAIN
ORDINANCES AND MAPS, AND DECLARING AN EMERGENCY

6 The Board of Commissioners hereby ORDAINS as follows:

7 SECTION I: COMPILATION

8 The attached compilation, consisting of the Lincoln
9 County Comprehensive plan, Lincoln County Planning and Zoning
10 ordinances and related ordinances, subdivision ordinance, major
11 and minor partitioning ordinances, and other ordinances by refer-
12 ence incorporated herein, and Lincoln County Plan and Zoning maps,
13 be adopted as chapter One of the Lincoln County Code. This ordi-
14 nance shall be referred to by short title as Lincoln County Code,
15 Chapter One.

16 SECTION II: PREVIOUS ORDINANCES/REPEALER

- 17 1. Lincoln County Zoning Ordinance #34, as amended,
18 is hereby repealed;
- 19 2. Lincoln County Comprehensive Plan Ordinance #175,
20 as amended, is hereby repealed except as follows:
- 21 a. Lincoln County Estuary Management Plan, as
22 adopted by exhibit "A" of Ordinance #184, as amended by Exhibit "A"
23 of Ordinance #193, is hereby incorporated as a part of chapter One.
- 24 b. Lincoln County Comprehensive Plan Goal Excep-
25 tions Paper, as adopted as Exhibit "DD" of Ordinance #183, as
26 amended by Exhibit "E" of Ordinance #187, is hereby incorporated

1 as a part of chapter One.

2 c. The Lincoln County Agricultural Land Priority
3 Rating System, as adopted in Ordinance #140, as amended in Ordi-
4 nance #175 and in Ordinance #183 Exhibit "CC", and in Ordinance
5 #187 Exhibit "D", is hereby adopted and incorporated by this
6 reference as a part of chapter One.

7 (d) Dredge Material Disposal Plan as adopted by
8 Ordinance #182 Exhibit "AA" is hereby adopted and by this refer-
9 ence is made a part of this ordinance.

10 (e) Lincoln County Plan and Zoning Maps as adopted
11 by Ordinance #183 and as subsequently amended are by this refer-
12 ence incorporated as part of chapter One.

13 SECTION III: FINDINGS

14 That the findings as shown by the record of the planning
15 commission and this Board during the adoption and/or amendment
16 of the Lincoln County Plan and Zoning Ordinances are hereby adopted
17 in their entirety.

18 SECTION IV: SEVERABILITY

19 If any portion of the Lincoln County Comprehensive Plan,
20 Zoning Ordinances, Subdivision Ordinance, Partitioning Ordinance,
21 or maps, is declared invalid or void, all other provisions of
22 this ordinance shall remain in effect.

23 SECTION V: EMERGENCY CLAUSE

24 This ordinance, being necessary for the immediate




