AN ORDINANCE AMENDING CHAPTER SEVEN, GENERAL ADMINISTRATION, SECTIONS 7.610 THROUGH 7.625, CREATING NEW PROVISIONS, DELETING PORTIONS THEREOF, AND DECLARING AN EMERGENCY

WHEREAS there is a need for increased regulation of parking facilities serving county premises in order to better serve the public; and

WHEREAS the parking facilities have expanded due to the removal of metal sheds on the courthouse premises thereby making available additional areas for public and employe parking; and

WHEREAS there is a need to revise existing ordinance provisions to apply to all employes of the state and county using the courthouse premises for parking;

NOW, THEREFORE, the Lincoln County Board of Commissioners ORDAINS as follows:

1. Section 7.615(1) is amended to read:

"Employes of the county and the state of Oregon shall not park in any parking space abutting the main courthouse building. Parking in the space abutting the courthouse by the public shall be limited to 90 minutes."

2. Adding to section 7.615 a new subsection (5) to read as follows:

"Any county or state employe vehicle parked upon the courthouse grounds during the hours of 8:00 a.m. to 5:00 p.m. excepting week ends, holidays, and employe days off, shall display a county parking sticker which must be conspicuously displayed on the rear window of all vehicles except motorcycles which shall have the stickers conspicuously placed in a reasonable manner."

3. Amending section 7.615(2) to read as follows:

"Only authorized persons shall park in any parking space designated for loading or for handicapped persons."

4. Amending section 7.615(3) to read as follows:

"Only authorized persons shall park in any parking space specifically designated for a particular individual or department."

5. Amending section 7.620, adding new subsection (3)

to read as follows:

1 "Only vehicles bearing a county parking sticker shall be
2 allowed to park in the center row of the courthouse parking lot and
3 in the area to the rear of the Public Services building, which
4 areas shall be prominently identified by appropriate signs."

5 6. Amending section 7.620, adding new subsection (4)
6 to read as follows:

7 "The personnel department shall be responsible for
8 compiling and maintaining current state and county employe names
9 and vehicle identifications to facilitate the issuance of permit
10 stickers."

11 That this ordinance, being necessary for the immediate
12 preservation of the public peace, health, and safety, an emergency
13 is declared to exist and this ordinance takes effect upon its
14 adoption.
