AN ORDINANCE AMENDING ORDINANCE #188, CHAPTER SEVEN, GENERAL
ADMINISTRATION, SECTION 7.505, FEES OF COUNTY CLERK, and
DECLARING AN EMERGENCY

The Lincoln County Board of Commissioners

ORDAINS

as follows:

Section 7.505 of the Lincoln County Code shall

7.505 Fees

The Lincoln County Clerk shall collect the following fees in addition to all other fees required by law:

- (1) \$1.25 for filing the termination of a cooperative contract as provided by ORS 62.360;
- (2) \$100 plus \$5 per lot for each subdivision checked by the county surveyor as provided by ORS 92.100;
- (3) \$5 for approval by the Board for subdivision plats as provided by ORS 92.044(3);
- (4) The schedule set forth below for recording and indexing subdivision plats as provided by ORS 92.120:
 - (a) \$10 for plats containing 20 lots or less;
 - (b) \$15 for plats containing over 20, but not more than 30 lots;
 - (c) \$20 for plats containing over 30, but not more than 50 lots;
 - (d) \$25 for plats containing over 50, but not more than 75 lots;
 - (e) \$30 for plats containing over 75, but not more than 100 lots;
 - (f) \$50 for plats containing over 100 lots, and 50¢ for each additional lot;


- (5) \$10 for filing an "Authority to Solemnize Marriages" as provided in ORS 106.120 and 205.320(16);
- (6) \$3.75 per page for preparing a true copy of a document not sufficiently legible to be reproduced photographically as provided in ORS 205.325;
- (7) \$25, plus \$10 per hour, for time spent in excess of two hours, for a lien search and certificate as provided in ORS 205.230 and 205.320(14);
- (8) \$1 for every tract or lot indexed in the direct or indirect index pursuant to ORS 205.340;
- (9) \$10 for the marking of vacations on an original plat by the county surveyor as provided by ORS 271.230(2);
- (10) \$10 for filing a notice of a mine claim or for a mining lien as provided in ORS 517.030;
- (11) \$10 for filing affidavits of labor on mining claims;
- (12) \$10 for a certificate of assessment work on a mining claim as provided in ORS 517.290.

1 That this ordinance, being necessary for the immediate
2 preservation of public peace, health, and safety, an emergency
3 is declared to exist, and this ordinance takes effect upon its
4 adoption.
