ORDINANCE # 228

AN ORDINANCE REPEALING CERTAIN PROVISIONS OF ORDINANCE #222, AS-SIGNING ROAD NAMES AND NUMBERS WITHIN THE TOLEDO ADDRESSING ZONE, AMENDING THE ORDINANCE TO CHANGE CERTAIN ROAD NAMES, and DECLARING AN EMERGENCY

WHEREAS, pursuant to section 6.115 of the Lincoln County Code, the traffic safety engineer, in consultation with the county road department, affected municipalities, and the city of Toledo, ascertained and recommended proper road names for the Toledo zone which names were duly adopted by Ordinance #222 by the Lincoln County Commissioners on October 31, 1984; and

WHEREAS, subsequent to the adoption of the ordinance changing said road names, the board of commissioners received input from the public that two of the road names required revision in that they were not consistent with historical practice in the respective areas; and

WHEREAS the board received public testimony at public hearings on the propriety of the Essex Loop name, with overwhelming public testimony to the effect that the proper name should be Yasek Loop; and

WHEREAS the board has received similar input regarding Summit Frontage Loop, the overwhelming public input being the proper name should be Cline Hill Loop; and

WHEREAS each of the subject road names was adopted by ordinance by the board of commissioners and requires amendment to the ordinance to officially change the road names.

Now, therefore, the board hereby ORDAINS as follows:

1. That those portions of Ordinance #222 providing for the names of Essex Loop and Summit Frontage Loop are hereby repealed;
2. That Ordinance #222 is hereby amended so that Essex Loop is amended to read "Yasek Loop", and Summit Frontage Loop is amended to read "Cline Hill Loop";
3. That the traffic safety engineer make appropriate revisions on the official county road maps, and place appropriate signs on the respective highways;

2 Lincoln County Road Department, Lincoln County Assessor's Office,
and Lincoln County Department of Planning and Development;

3 5. That this ordinance, being necessary for the imme-
4 diate preservation of the public peace, health, and safety, an
emergency is declared to exist and this ordinance takes effect upon
5 its adoption.
