AN ORDINANCE REPEALING CERTAIN PROVISIONS OF ORDINANCE #222, AS-SIGNING ROAD NAMES AND NUMBERS WITHIN THE TOLEDO ADDRESSING ZONE, AMENDING THE ORDINANCE TO CHANGE A CERTAIN ROAD NAME, AND DECLARING AN EMERGENCY

WHEREAS, pursuant to section 6.115 of the Lincoln County Code, the traffic safety engineer, in consultation with the county road department, affected municipalities, and the city of Toledo, ascertained and recommended proper road names for the Toledo zone which names were duly adopted by Ordinance #222 by the Lincoln County Commissioners on October 31, 1984; and

WHEREAS, subsequent to the adoption of the ordinance changing said road names, the board of commissioners received a petition from the public that a road name required revision; and

WHEREAS the board after consultation with the traffic safety engineer, has determined that the name Eddyville-Blodgett Road should be changed to Nashville Road; and

WHEREAS the subject road name was adopted by ordinance by the board and requires amendment to the ordinance to officially change the road name;

Now, therefore, the board hereby ORDAINS as follows:

1. That that portion of Ordinance #222 providing for the name of Eddyville-Blodgett Road is hereby repealed;

2. That Ordinance #222 is hereby amended so that Eddyville-Blodgett Road is amended to read "Nashville Road";

3. That the traffic safety engineer make appropriate revisions on the official county road maps and place appropriate signs on the respective roads;

4. That copies of this ordinance be furnished to the Lincoln County Road Department, Assessor's Office, and Department of Planning and Development;

5. That this ordinance, being necessary for the immediate preservation of the public peace, health, and safety, an
