ORDINANCE # 259

AN AMENDMENT TO CERTAIN PROVISIONS OF ORDINANCE #238, ASSIGNING ROAD NAMES AND NUMBERS WITHIN THE DEPOE BAY AND WALDPART ZONES TO CHANGE CERTAIN ROAD NAMES, AND DECLARING AN EMERGENCY

WHEREAS, pursuant to LCC 6.116, the traffic safety engineer, in consultation with the road department, affected municipalities, and the cities of Depoe Bay and Waldport, ascertained and recommended proper road names for the Depoe Bay and Waldport zones, which names were duly adopted by ordinance #238; and

WHEREAS, subsequent to the adoption of said ordinance, the board received input from the public that several of the road names require revision to conform with public preference in these areas; and

WHEREAS each of the subject road names were adopted by ordinance by the board and requires amendment to the ordinance to officially change the road names;

Now, therefore, it is hereby ORDAINED as follows:

1. That those portions of Ordinance #238 assigning road names and numbers within the Waldport addressing zone are amended as follows:

<u>Road Number</u>	<u>Road Name Changes</u>
1066	East Dussler Lane to East Roe Lane
8622	Southwest Minnewawa Avenue to Southwest Waziyata Avenue
8637	Southwest St. Clair Lane to Southwest Alicia Lane

2. That those portions of Ordinance #238 assigning road names and numbers within the Depoe Bay addressing zone are amended as follows: (see Exhibit "A" attached hereto and made part of this ordinance)

Change 6121 El Mirador and 6120 El Poco to Escondido 6111

Change westerly portion of El Cerrito (6118) to El Mar Avenue (6097), beginning at Coronado Drive North (6119) and running north continuously to intersect with Hacienda Avenue (6098); therefore, El Cerrito Avenue will become a connecting road between El Mar Avenue (6097) and Hacienda Avenue (6098).

Private road identified as tax lot 18102 to be named El Mar Court (1097).

Change westerly portions of Coronado Drive North, Coronado Drive South, and El Mirador Drive (6126) to El Mundo Avenue (6112) to extend south to beach access; therefore El Mundo Avenue is a continuous street (6112).

3. That the county traffic safety engineer make appropriate revisions on the official county road maps and in the official county records reflecting these amendments and place appropriate signs on the respective roads;

4. That copies of this ordinance be furnished to the road department, assessor's office, and the Planning and Development Department.

5. That this ordinance, being necessary for the immediate preservation of the public peace, health, and safety, an emergency is declared to exist and this ordinance takes effect upon its adoption.
