AN ORDINANCE REPEALING CERTAIN PROVISIONS OF ORDINANCES ##226 and 238,
ASSIGNING ROAD NAMES AND NUMBERS WITHIN THE YACHATS AND WALDPART AD-
DRESSING ZONES, AMENDING THE ORDINANCES TO CHANGE CERTAIN ROAD NAMES,
and DECLARING AN EMERGENCY

WHEREAS, pursuant to Lincoln County Code 16.115, the traf-
fic safety engineer, in consultation with the road department, affec-
ted municipalities, and the cities of Yachats and Waldport, ascer-
tained and recommended proper road names for the Yachats and Waldport
zones, which names were duly adopted by ordinances 226 and 238; and

WHEREAS, subsequent to the adoption of said ordinances,
the board received input from the public that three of the road
names require revision to conform with public preference in these
areas; and

WHEREAS each of the subject road names was adopted by or-
dinance by the board and requires amendments to the ordinances to
officially change the road names;

Now, therefore, the board hereby ORDAINS as follows:

1. That those portions of ordinance #226 providing for
the names of Northwest and Northeast San Marine Streets, road numbers
9036 and 9138, hereby are repealed;

2. That ordinance #226 is hereby amended so that road
number 9036 NE San Marine Street is now 9036 NE Wyoming Street; and
road number 9138 NW San Marine Street is now 9138 NW Wyoming Street;

3. That that portion of ordinance #238 providing for
the name of SW Burke Lane is hereby repealed;

4. That ordinance #238 is hereby amended so that road
number 9017 SW Burke Lane is now road number 9017 SW Iris Lane;

5. That the traffic safety engineer make appropriate re-
visions on the official county road maps and place appropriate signs
on the respective roads;

6. That copies of this ordinance be furnished to the road
department, the assessor's office, and the planning and development
department;
