5 AN ORDINANCE AMENDING ORDINANCE NOS. 205, 275, and 276 ASSIGNING  
6 NEW ROAD NAMES WITHIN THE NEWPORT ADDRESSING ZONE AND DECLARING  
7 AN EMERGENCY

8 WHEREAS on December 7, 1983, the Board adopted a  
9 comprehensive plan providing for a uniform system of addressing  
10 and numbering all houses and buildings within the jurisdiction of  
11 the county and providing for a method of clarifying duplicate  
12 road and highway names and assigning new road names and numbers;  
13 and

14 WHEREAS, pursuant to LCC 6.115, the Traffic Safety  
15 Engineer, in consultation with the County Road Department and  
16 affected municipalities, and the City of Newport ascertained  
17 proper road names and numbers for the Newport Zone, and the Board  
18 adopted those recommended road names and numbers in Ordinances  
19 205 and 275, which were later amended by Ordinance 276; and

20 WHEREAS the Board has received a petition requesting  
21 changes in the names of several streets in the Newport Addressing  
22 Zone, and the Board having reviewed recommendations, having  
23 published notice as required, and received public input as to the  
24 propriety of the proposed changes within the Newport Addressing  
25 Zone and having determined that the proposed changes are in the  
26 public interest;

27 NOW, THEREFORE, THE BOARD HEREBY ORDAINS AS FOLLOWS:

28 SECTION I:

29 That those portions of Ordinances No. 205, 275, and 276  
30 assigning road names and numbers within the Newport Addressing  
31 Zone are amended as follows:

<u>Road Number</u>	<u>Road Name Changes</u>
7805	SE Isaac Court to SE Kendal Court
7850	SE Isaac Road to SE Johnston Lane

32 SECTION II:

33 That the County Traffic Safety Engineer and the  
34 Addressing Technician make appropriate revisions on the official  
35 county road maps and the official addressing maps reflecting

these amendments.

SECTION III:

That copies of this ordinance be furnished to the Road Department, Assessor's Office, and the Addressing Office of the Department of Planning and Development.

SECTION IV:

That the Addressing Department change all addressing data bases to reflect the adopted street names, notify all property owners and emergency service agencies by mail of the street name changes, and initiate procedures to change street signs on Yaquina Bay Road to reflect the adopted street names.

SECTION V:

That this ordinance, being necessary for the immediate preservation of the public peace, health, and safety, an emergency is declared to exist and this ordinance takes effect upon its adoption.
