3 ORDINANCE NO. 290

4 AN ORDINANCE AMENDING ORDINANCE #155, CONTRACT REVIEW BOARD  
5 REQUIREMENTS, LINCOLN COUNTY CODE SECTION 7.020(3), AND DECLARING  
6 AN EMERGENCY

7 WHEREAS the Board of Commissioners desires to amend the  
8 Local Contract Review Board Requirements as set forth in Lincoln  
9 County Code Section 7.020(3) to coincide with current  
Administrative Rules in effect for State of Oregon purchasing;

10 NOW, THEREFORE, IT IS HEREBY ORDAINED AS FOLLOWS:

11 SECTION 1:

12 That the Contract Review Board requirements adopted as part  
13 of the Lincoln County Code in Ordinance #155 be amended as  
14 follows (additions in boldface; deletions in brackets):

15 7.020(3): Contracts for purchase where the amount does not  
16 exceed [~~\$10,000~~] **\$15,000**.

17 (a) If contracts are for more than [~~\$5,000~~] **\$7,500**,  
18 at least three competitive quotes shall be  
19 obtained where practicable. A written record  
20 shall be made containing the source and amount  
21 of quotes received.

22 (b) If contracts are for more than [~~\$500~~] **\$1,000**  
23 but less than [~~\$5,000~~] **\$7,500**, competitive  
24 quotes may be obtained where practicable.

25 (c) No contractor may be awarded, in the aggregate,  
26 within the fiscal year, contracts in excess of  
27 \$20,000 under this subsection without  
28 competitive bids. In computing the aggregate  
29 under this subsection, awards under [~~\$500~~]  
30 **\$1,000** need not be included.

31 SECTION 2: EMERGENCY CLAUSE

32 This ordinance, being necessary for the immediate  
33 preservation of public peace, health, and safety, an emergency


