ORDINANCE NO. 276

AN ORDINANCE AMENDING ORDINANCE NOS. 205, 238, 258, 259, 266, AND 275 ASSIGNING NEW ROAD NAMES AND NUMBERS WITHIN THE NEWPORT, LINCOLN CITY, AND DEPOE BAY ADDRESSING ZONES AND DECLARING AN EMERGENCY

WHEREAS on December 7, 1983, the Board adopted a comprehensive plan providing for a uniform system of addressing and numbering all houses and buildings within the jurisdiction of the county and providing for a method of clarifying duplicate road and highway names and assigning new road names and numbers; and

WHEREAS, pursuant to LCC 6.115, the Traffic Safety Engineer, in consultation with the County Road Department and affected municipalities, and the Cities of Newport, Lincoln City, and Depoe Bay, ascertained proper road names and numbers for the Newport Zone, Lincoln City Zone, and Depoe Bay Zone and the Board adopted those recommended road names and numbers; and

WHEREAS the Board has reviewed recommendations, published notice as required, and received public input as to the propriety of additional road name and road number changes for public and private roads within the Newport, Lincoln City, and Depoe Bay addressing zones and has determined that the proposed changes are in the public interest; and

NOW, THEREFORE, THE BOARD HEREBY ORDAINS AS FOLLOWS:

SECTION I:

That those portions of Ordinances No. 205, 258, and 266 assigning road names and numbers within the Lincoln City addressing zone are amended as follows:

<u>Road Number</u>	<u>Road Name Changes</u>
1004	Parnell Road to Mountain View Road

SECTION II:

That those portions of Ordinances No. 205, and 275 assigning road names and numbers within the Newport addressing zone are amended as follows:

<u>Road Number</u>	<u>Road Name Changes</u>
7903	S.W. Surfland Court--east off S.W. Surfland Street and south of SW 77th Court (addition)
7035	NE Beverly Lane--north off NE Beverly Drive, 4 S of NE 123rd Street

SECTION III:

That those portions of Ordinance No. 259 assigning road names and numbers within the Depoe Bay addressing zone are amended as follows:

<u>Road Number</u>	<u>Road Name Changes</u>
6119	Coronado Drive to Shore Drive
6110	Shore Drive to Coronado Drive

Map marked Exhibit "A", change Pacific Palisades to Palisades Drive

Change wording paragraph 2, page 2, to read as follows: (Additions boldface; deletions bracketed)

Change westerly portion of El Cerrito (6118) to El Mar Avenue (6097); therefore beginning at [Coronado] Shore Drive [North (6119) and running] El Mar Avenue runs north continuously to intersect with Hacienda Avenue [(6098)]; therefore, El Cerrito Avenue will become a connecting road between El Mar Avenue (6097) and Hacienda Avenue (6098)].

SECTION IV:

That the County Traffic Safety Engineer make appropriate revisions on the official county road maps in the official county records reflecting these amendments and place appropriate signs on the respective roads;

SECTION V:

That copies of this ordinance be furnished to the Road Department, Assessor's Office, and the Planning and Development Department.

SECTION VI:

That this ordinance, being necessary for the immediate preservation of the public peace, health, and safety, an

emergency is declared to exist and this ordinance takes effect upon its adoption.
