3 ORDINANCE # 299

4 AN ORDINANCE AMENDING ORDINANCE NO. 155 AND LINCOLN COUNTY
5 CODE SECTIONS 2.405 THROUGH 2.445, "SUBSURFACE SEWAGE," AND
DECLARING AN EMERGENCY

6 WHEREAS Sections 2.405 through 2.445 were enacted for
7 "...the purpose of ensuring that adequate and safe sewage
8 disposal installations are provided..." in Lincoln County; and

9 WHEREAS the Code establishes fees to accompany applications
10 submitted for permits, licenses, and other services as required
11 by state law under ORS Chapter 454; and

12 WHEREAS the Board desires to amend the procedure for
13 setting those fees to require annual review and updating of the
14 fee schedule;

15 NOW, THEREFORE, THE BOARD ORDAINS AS FOLLOWS:

16 SECTION I

17 Lincoln County Code Section 2.425 as currently written is
18 hereby deleted and replaced as follows:

19 "2.425 FEES

20 (1) A fee schedule for applications for permits,
21 licenses, and services provided for in ORS Chapter
22 454 shall be set by resolution of the Board of
23 Commissioners which shall be subject to amendment
24 from time to time. An annual review of the fee
25 schedule shall occur during the month of January
26 with recommendations for changes made by the
Department of Planning and Development. The Board
shall consider the proposed changes as a discussion
item at an open public meeting at least thirteen
(13) days prior to the date of adoption of an
amended resolution changing the fee schedule.

(2) The fee schedule shall also include fees for
renewals, evaluation reports and feasibility soils
and studies."
