3 ORDINANCE # 300

4 AN ORDINANCE AMENDING ORDINANCE NO. 155 AND LINCOLN COUNTY
5 CODE SECTION 1.1220, "LAND USE PLANNING AND ZONING," AND
6 DECLARING AN EMERGENCY

7 WHEREAS Chapter 1 of the Lincoln County Code was enacted
8 for the purpose of establishing a comprehensive plan and
9 implementing land use regulations in Lincoln County; and

10 WHEREAS the Code establishes fees to accompany applications
11 submitted for land use actions, permits, and other services
12 required pursuant to ORS Chapter 197; and

13 WHEREAS, acting upon the recommendation of the Lincoln
14 County Planning Commission, after public hearing held May 28,
15 1991, to consider amendment to the Lincoln County Code, the Board
16 desires to amend the procedure for setting these fees to require
17 annual review and updating of the fee schedule;

18 NOW, THEREFORE, THE BOARD ORDAINS AS FOLLOWS:

19 SECTION I

20 Lincoln County Code Section 1.1220 as currently written is
21 hereby deleted and replaced as follows:

22 "1.1220 FEES

- 23 (1) For the purpose of defraying the cost of processing
24 applications, fees shall be paid to the Planning
25 Division upon the filing of an application.
- 26 (2) A fee schedule for applications provided for in
this Chapter shall be set by resolution of the
Board of Commissioners after review and
recommendation by the Planning Commission. An
annual review of the fee schedule shall occur
during the month of January, with recommendations
for changes made by the Department of Planning and
Development. The Planning Commission shall
consider the proposed changes at a public hearing
and, upon conclusion of the hearing, shall make a
recommendation regarding the proposed changes to
the Board of Commissioners."

1 SECTION II: EMERGENCY CLAUSE

2 This ordinance, being necessary for the immediate
3 preservation of the public peace, health and safety, an emergency
4 is declared to exist and this ordinance takes effect upon its
5 adoption.
