ORDINANCE NO. 307

AN ORDINANCE AMENDING ORDINANCE NO. 155 AND LINCOLN COUNTY CODE SECTION 7.505 BY ESTABLISHING NEW PROCEDURES FOR SETTING FEES OF THE COUNTY CLERK AND DECLARING AN EMERGENCY

WHEREAS previously fees of the County Clerk have been set by ordinance through amendment of the Lincoln County Code in Section 7.505; and

WHEREAS these fees are in addition to other fees as required by law and include fees set under authority of ORS 62.360, 92.100, 92.044(3), 106.120, 205.320(16), 205.325, 205.230, 205.320(14), 205.340, 271.230(2), 517.030, 517.290, and other authority; and

WHEREAS the fees were revised in 1982, 1983, and 1989 by Ordinance No. 279; and

WHEREAS the Board, in reviewing fees for the County, desires to amend the procedure for setting those fees to require an annual review and updating of the fee schedule;

NOW, THEREFORE, THE BOARD ORDAINS AS FOLLOWS:

SECTION 1

Lincoln County Code Section 7.505 as currently written is hereby deleted and replaced as follows:

"7.505 FEES

The Lincoln County Clerk may collect fees in addition to all other fees required by law which shall be set by resolution approved by the Lincoln County Board of Commissioners after review at a public meeting. An annual review of the fee schedule shall thereafter occur during the month of January. The Clerk, Surveyor and any other county official(s) whose fees are collected by the Clerk may make recommendations for any changes to the fee schedule during the annual review. The Board may consider other changes it deems appropriate. Annual review shall not prohibit further periodic review and updating of the schedule in accordance with law."
