ORDINANCE NO. 327

AN ORDINANCE AMENDING LINCOLN COUNTY COMPREHENSIVE PLAN BY GRANTING AN EXCEPTION TO STATEWIDE PLANNING GOALS 3 (AGRICULTURAL LANDS) AND 4 (FOREST LANDS) FOR REALIGNMENT OF U.S. ROUTE 20 BETWEEN EDDYVILLE AND CLINE HILL AND DECLARING AN EMERGENCY

WHEREAS the Lincoln County Planning Commission, after legal notice, held a public hearing on October 25, 1993, to consider a request from the Oregon State Department of Transportation, Highway Division, to amend the Lincoln County Comprehensive Plan by granting an exception to Statewide Planning Goals 3 (Agricultural Lands) and 4 (Forest Lands) for realignment of U.S. Route 20 between Eddyville and Cline Hill, Case File No. 2-TA-93; and

WHEREAS the property which is the subject of this requested plan amendment is generally identified as that portion of U.S. Route 20 (Corvallis-Newport Highway) extending from Milepoint 24.75 east to Milepoint 29.5 in Lincoln County, Oregon; and

WHEREAS at the conclusion of the hearing the Planning Commission voted 6-1 to recommend approval of the request to the Board of Commissioners; and

WHEREAS after published notice in accordance with law, the Lincoln County Board of Commissioners held a hearing on the 22nd day of December, 1993, to consider the amendment and statewide goal exceptions; and

WHEREAS at the conclusion of that hearing, the Board voted to approve the request as submitted;

NOW, THEREFORE, IT IS HEREBY ORDAINED AS FOLLOWS:

1. That the request for amendment to the Lincoln County Comprehensive Plan by granting an exception to Statewide Planning Goals 3 and 4 for realignment of US Route 20 between Eddyville and Cline Hill, generally defined as that portion of US Route 20 (Corvallis-Newport Highway) extending from Milepoint 24.75 east to Milepoint 29.5, is approved and the exception is hereby granted. Approval is based upon the materials submitted by the applicant in support of its request including, but not limited to, the background documents contained in the record before the county and the findings and conclusions found in pages 5-15 of the *Exception to Statewide Planning Goals 3&4 Authorizing the Realignment of US Route 20 Between Eddyville and Cline Hill, Lincoln County, Oregon*, all of which are incorporated herein as if fully set forth.
