9                   The Lincoln County Board of Commissioners ordains as follows:

10                   **SECTION 1.**

11                   Sections 2 through 5 of this Ordinance are added to and made apart of LCC Chapter  
12 7, as indicated.

13                   **SECTION 2.**

14                   **7.550 Definitions for LCC 7.550 to 7.580**

15                   **As used in LCC 7.550 to 7.580:**

16                   (1) **“County building” means any enclosed building owned or leased by Lincoln**  
17 **County**

18                   (2) **“Smoking instrument” means any cigar, cigarette, pipe or other smoking**  
19 **equipment.**

1           **SECTION 3.**

2           **7.560 Policy.**

3           **The Lincoln County Board of Commissioners finds that because the smoking of**  
4 **tobacco creates a health hazard to those present in confined places, it is necessary to**  
5 **reduce exposure to tobacco smoke by requiring nonsmoking areas in certain places.**

6           **SECTION 4.**

7           **7.570 Smoking Prohibited Except in Designated Areas**

8           **Upon any County owned or leased property, no person shall smoke or carry any**  
9 **lighted smoking instrument in a county building or within 25 feet of any county**  
10 **building, except in areas designated as smoking areas pursuant to LCC 7.580.**

11           **SECTION 5.**

12           **7.580 Designating Areas Where Smoking Permitted; Changing Areas; Posting**  
13 **Signs.**

14           **(1) The Lincoln County Board of Commissioners may designate areas in which**  
15 **smoking is permitted.**

16           **(2) The Lincoln County Public Works Department shall post appropriate signs**  
17 **indicating areas in which smoking has been permitted by the Board of Commissioners.**

18           **SECTION 6.**


19           **This Ordinance being necessary for the immediate preservation of the public peace,**  
20 **health and safety, an emergency is declared to exist and this Ordinance shall take effect upon**  
21 **its passage.**




