10 respective district, and the term of office for a board member shall be four years
11 commencing on July 1 following the date of election.

12 (4) ORS chapter 255 governs the nomination and election of the board members and
13 the conduct of the elections.

14 (5) The first elected board of each special road district identified in subsection (1)(a)
15 through (c) of this section shall be elected on the third Tuesday in May of 2003. In
16 accordance with ORS 371.349(2) and notwithstanding the four-year term of office described
17 in subsection (3) of this section, for each first board elected, the term of one board member
18 shall end on June 30, 2005, as designated by the County Clerk.

19 (6) The first elected board of the special road district identified in subsection (1)(d)
20 of this section shall be elected on the third Tuesday in May of 2005. In accordance with
21 ORS 371.349(2) and notwithstanding the four-year term of office described in subsection (3)




