



1 (3) In accordance with ORS 371.349(1), the board of each district identified in subsection  
2 (1) of this section shall consist of three members elected by the electors of each respective district,  
3 and the term of office for a board member shall be four years commencing on July 1 following  
4 the date of election.

5 (4) ORS chapter 255 governs the nomination and election of the board members and the  
6 conduct of the elections.

7 (5) The first elected board of each special road district identified in subsection (1)(a)  
8 through (c) of this section shall be elected on the third Tuesday in May of 2003. In accordance  
9 with ORS 371.349(2) and notwithstanding the four-year term of office described in subsection (3)  
10 of this section, for each first board elected, the term of one board member shall end on June 30,  
11 2005, as designated by the County Clerk.

12 (6) The first elected board of the special road district identified in subsection (1)(d) of this  
13 section shall be elected on the third Tuesday in May of 2005. In accordance with ORS  
14 371.349(2) and notwithstanding the four-year term of office described in subsection (3) of this  
15 section, for each first board elected, the term of one board member shall end on June 30, 2007, as  
16 designated by the County Clerk.

17 (7) The first elected board of the special road district identified in subsection (1)(e) of this  
18 section shall be elected on the third Tuesday in May 2013. In accordance with ORS 371.349(2)  
19 and notwithstanding the four year term of office described in subsection (3) of this section, for  
20 each first board elected, the term of one board member shall end on June 30, 2015, as designated  
21 by the County Clerk.

22 (8) The first elected board of the special road district identified in subsection (1)(f) of this  
23 section shall be elected on the third Tuesday in May 2018. Notwithstanding the four year term of  
24 office described in subsection (3) of this section, for each first board elected, the term of one  
25 board member shall end on June 30, 2019, and the term of the other two board members shall end  
26 on June 30, 2021, as designated by the County Clerk.

27 **(9) The first elected board of the special road district identified in subsection (1)(g) of**  
28 **this section shall be elected on the first Tuesday in November, 2021. In accordance with**  
29 **ORS 371.349(2), and notwithstanding the four- year term of office described in subsection**

1 (3) of this section, for each first board elected, the term of one board member shall end on  
2 June 30, 2023, and the other two board members shall end on June 30, 2025, as designated  
3 by the County Clerk.

4 [(8)] (9) (10) In accordance with ORS 371.318(3), the County shall pay the costs of  
5 conducting the elections at which the board members are elected.

6 **SECTION 2.**


7 The sections, subsections, paragraphs and clauses of this Ordinance are severable. The  
8 invalidity of one section, subsection, paragraph or clause shall not affect the validity of the  
9 remaining sections, subsections, paragraphs and clauses.

10 **SECTION 3.**


11 This ordinance was first read on July 12, 2021, and a second reading was made on July 19,
