ORDINANCE NO. 530

---

Amending Ordinance #471 relating to environmental health, and creating new provisions

---

WHEREAS, Lincoln County Health and Human Services is in the midst of Public Health re-accreditation with the Public Health Accreditation Board; and

WHEREAS, the re-accreditation process requires that documents, policies and ordinances be updated to within five (5) years of the re-accreditation process in order for Lincoln County to successfully apply; and

WHEREAS, Ordinance No. 471, which delegates to Lincoln County at the local level certain environmental sanitation programs, was adopted in 2014 which is more than five years in the past; and

WHEREAS, Ordinance No. 471 is in need of minor updating and amendments;

**NOW, THEREFORE, THE LINCOLN COUNTY BOARD OF  
COMMISSIONERS ORDAINS AS FOLLOWS:**

- 1) Lincoln County Ordinance No. 471 is amended as shown on Exhibit "A", which is attached hereto and incorporated by reference. Exhibit "A" represents the original Ordinance 471, but without the emergency passage language and the signature section.

1 Lincoln County hereby adopts ORS Ch. 448, together with subsequent amendments, **and**  
2 **OAR 333-060-0005 to 333-060-0705, and 333-062-0005 to 333-062-0255**, as it relates to  
3 the delegation of responsibilities of the Assistant Director for Health regarding Swimming  
4 Facilities, pursuant to ORS 448.100 with the exception of plan review duties for and  
5 swimming pools and spas.

6 **SECTION 4 2.1815: FOOD SERVICE FACILITIES**

8 Lincoln County hereby adopts ORS Ch. 624, together with subsequent amendments, **and**  
9 **OAR 333 Division 150, 333-012-0050 to 333-012-0070, 333-170-0000 to 333-170-0130,**  
10 **333-162-0020 to 333-162-1005, 333-175-0001 to 333-175-0111, and 333-039-0005 to 333-**  
11 **039-0055**, as it relates to the delegation of responsibilities of the Assistant Director for  
12 Health regarding Restaurants and Bed & Breakfast Facilities, pursuant to ORS 624.510.

13 **SECTION 5 2.1820: OREGON ADMINISTRATIVE RULES**

14  
15 Lincoln County hereby adopts OAR ~~333-12-050, 333-12-055, 333-12-060, 333-12-065,~~  
16 **333-012-0050, 333-012-0055, 333-012-0060 and 333-012-0065** together with subsequent  
17 amendments, as it relates to the delegation of responsibilities of the Assistant Director for  
18 Health as described in this division.

19 **SECTION 6 2.1825: EFFECTIVE DATE OF DELEGATION**

21 The delegation of duties as described in this division shall be effective on the date as  
22 mutually agreed by the State and County or such other date as determined by the Lincoln  
23 County Board of Commissioners.

24 **SECTION 7 2.1830: ENFORCEMENT**

1 Any state laws or administrative rules and any county ordinance or county rules relating to  
2 public health inspections and the delegation of authority to Lincoln County, including but  
3 not limited to this division and any rules adopted by the County pursuant to this division,  
4 shall be enforceable through the provisions of Chapter Ten, of the Lincoln County Code  
5 and/or by any applicable enforcement provisions provided by state law or administrative  
6 rule.




“All other substantive (LCC) provisions of Ordinance No. 471 shall remain the same.


